PART II

IRBM Technical Skills & Competency Strengthening

Building upon the results foundation established in Part 1 on Integrated Results-Based Management (IRBM), participants are now poised for Part 2, a pivotal phase in acquiring essential detailed knowledge & technical skills for IRBM implementation.

The Part 2 program offers a hands-on learning experience through practical case exercises. Each participant learns to apply specific IRBM tools and techniques to the organization's programs and/or projects.

The focus is on designing & developing valid outcomes-driven performance plans, and complementing them with results-based M&E plans. This is then supported with a practical performance information & decision-support system.

Participants will be equipped with detailed knowledge and skills for managing key aspects of the IRBM system for practical implementation.



PART III

IRBM Demonstration of Learning & Teaching

Part 3, the concluding phase of the 'Certified IRBM Practitioner' course, centers on participants demonstrating their knowledge and skills of all aspects of the IRBM system.

This segment will also work on the ability of participants to demonstrate their competencies in applying the key approaches, tools and techniques on all components of the IRBM system.

Participants will be required to design and build a fully functional integrated strategic results framework and to demonstrate their skill and competency with managing all system elements and their functionalities.

Active case studies and real-life simulations will enable participants to gain adequate skills and confidence to not only design and build a robust IRBM system but to also demonstrate their skills on applying the IRBM system for their organization.

- Ability to design and implement the IRBM System for own organization



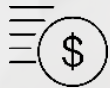
WHO SHOULD ATTEND THIS PART II & III COURSE

Exemptions may be considered for other IRBM trainers who have undergone IRBM basic training and were certified under the earlier IRBM ToT program for the Government of Zimbabwe. Other trainers who wish to join the course must show evidence of proficiency on the basic level of IRBM.
